

Effective Training for NEETs



The main objective of this project is to develop and improve the effectiveness of training offered to young adults who are NEETs.

The project began in September 2014 and during the first phase the project partners have been busy researching and collecting data by sending out questionnaires to the project's Target Group organisations all over Europe.

The research collected will determine and establish:

- the identification of the actors connected to the NEET sector;
- what training programs are currently offered to the NEETs;
- which key competence elements are common and which are not;
- which categories of training elements exist;
- what, if any, are the published results of current training schemes;
- what are the current National policy measures;
- a directory of social services (identified);
- a directory of suitable training providers (within partner countries); and
- what are the most recent studies, reports and publications relating to NEET issues;

To present and compare this data the project team will design and build a Matrix software tool that will be uploaded to the project's web Platform.

The Web Platform will also be used by and aid those involved in providing services or training to the NEET sector Europe-wide.

It will provide:

- a place where stakeholders and interested parties can offer and present data, publications, studies and reports on the subject of NEETs;
- a place where local authorities and organisations that offer training programs for NEETs, will gain a wider understanding of each others systems and training programs;
- a place to publish best use of training program results and exchange of best practice;
 - a place where the NEETs can relay and impart experiences, opinions and suggestions with regard to training programs attended or available; and
- a place where organisations can come together to form new networks and associations to especially provide better training and form a Community of Practice where Best Practice methods are available to use, test or discuss.

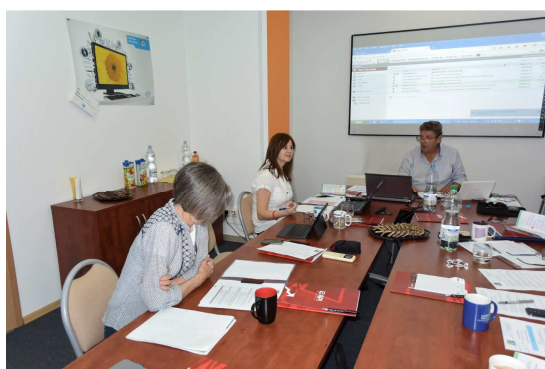
From the Analysis of the Data the project partners will produce a Preliminary Report on Best Practices which will be ready in October 2015

So far the partners have sent over 3,000 questionnaires to its Target Groups and a direct dialog has been started.
